#### PR MAUNA KEA LLC – INSURANCE REQUIREMENTS-

1. PR Mauna Kea LLC and its affiliates named below (collectively, "Parker Ranch") require an original Certificate(s) of Insurance at least five (5) days prior to your entry on Parker Ranch land(s) providing evidence of the coverage checked on page 2 of this form from an insurance company reasonably acceptable. Insurance costs are at your expense and the coverage shall remain in effect for the duration of your entry on any Parker Ranch land(s) and/or your business dealings with Parker Ranch, whichever is later, including, without limitation, the preparation and clean-up phases of your work or your function. If you are a vendor, coverage shall remain in effect for the duration that your services/products are supplied to PR Mauna Kea LLC or any of its affiliates listed below.

2. PR Mauna Kea LLC, and the affiliates named below, and their respective Trustees, officers, directors, shareholders, managers, members and employees must be named as additional insured's.

3. The wording for the Certificate should be as follows:

In the description of operations box on insurance application please list information below:

PR Mauna Kea LLC and the affiliates named below, and their respective Trustees, officers, agents, directors, shareholders, managers, members and employees are included as additional insureds.

- Parker Land Trust
- Richard Smart Revocable Personal Trust
- Parker Ranch Inc.

4. To the extent applicable, the insurance required below shall (i) provide that the insurance you obtain shall be primary to any insurance Parker Ranch may have in force which also applies to a loss covered by your policies and that the insurer will not seek contribution from insurance available to Parker Ranch; (ii) require that the insurer will give Parker Ranch written notice of cancellation of the policy or policies at least thirty (30) days before the effective date of the cancellation; and (iii) be "occurrence" form only ("claims made" forms are not acceptable), with a provision that defense costs are paid in addition to and do not deplete any policy limits. Certificates must contain the appropriate language for the primary and non-contributory requirements set forth above.

5. Required coverage and the limits for such coverage shall be (as checked):

- a.  \$1,000,000 Per Occurrence – Commercial General Liability
- b.  \$2,000,000 Products/Completed Operations Liability Aggregate if applicable – Vendor or Contractor.
- c.  \$2,000,000 General Aggregate
- d.  \$1,000,000 Liquor Liability (If serving, selling or distributing alcoholic beverages on any Parker Ranch land or for a Parker Ranch Event).
- e. \_\_\_\_\_ \$1,000,000 Auto Liability Combined Single Limit or equivalent if vehicles will be driven on Parker Ranch lands.\*\*\* this is the minimum amount required \*\*\*
- f. \_\_\_\_\_ Statutory Workers' Compensation and \$100/\$500/\$100,000 Employers Liability if Certificate Holder has employees on Parker Ranch Lands.
